Landfill Fees*

These fees apply to garbage (normal household waste), large items (furniture, toys, bikes, grills, stoves, washers, dryers, and small appliances) and demolition/construction (wood, drywall, doors, flooring, windows, sinks, and roofing). Other materials such as brush, yard waste, tires, and freon containing appliances (air conditioners, dehumidifiers, and refrigerators) have different fees. Trailers, Cargo Van, UHAULS, Businesses (Including Landlords):



All landfill customers must drive onto the inbound scale. Only people authorized by site attendants may use the facility. You must provide your own labor for unloading materials. Due to safety concerns, we do not permit salvaging once waste is placed in the container.

Information and Directions

* PLEASE READ SIGNAGE*

Things have changed at the landfill. The Solid Waste Department recently redesigned the entrance to the Landfill site on Highway 16 to improve efficiency and safety. Our new site address is 3240 Berlin Drive. The diagram to the right illustrates this new entrance. Department staff are available at the main office, the Household Hazardous Materials (HHM) facility and the new scale facility to provide further instruction when you enter the site. The landfill entrance now features two scales, inbound and outbound. All customers must scale in on the inbound scale. Access to the main office has also changed. The entrance door and parking are now located on the southeast side of the building. Access to the Reuse Room is now located directly across from the HHM canopy. For information on changes to the Household Hazardous Materials Facility Entrance and the Reuse Room please see the reverse side of this flyer.

Animals

Owners of dogs in Town of Bangor must purchase a yearly license for each dog. Contact Rodney Nicolai, the Town of Bangor Treasurer, at 608-486-4249. License cost for a spayed or neutered animal is \$11.00. Cost for non-altered animals is \$21.00. License must be obtained between January 1 and April 1. They may be purchased from the Town Treasurer January 1-31. After that they may be obtained from the County Clerk. Puppies must be licensed once they are five months old.

To report a lost or found animal, call the Coulee Region Humane Society. You may also contact them if you find it necessary to surrender a pet. If a person has been bitten by an owned animal, please contact the Sheriff's Department to initiate a bite report. If the animal is running at large contact Animal Control at the Coulee Region Humane Society.

Elections and Voting

Voting: Residents of the Town of Bangor may vote between 7:00 am and 8:00 pm at the Bangor Town Hall, located at N4400 State Road 162, Bangor Wisconsin.

Voter Registration: If a resident has not voted in the Township, or has a change of address, they must fill out a Voter Registration Form. They must show proof that they have lived in the Township for 28 days prior to the election. Acceptable forms of proof can be driver's license or utility bills.

Absentee Voting: Absentee voting can be done by mail or in person.

To vote **in person**, the resident should contact the Town Clerk and arrange to vote. Recent law changes restrict voting to the two weeks prior to the election. Absentee voting ends the Friday before the election No ballots can be cast the Saturday, Sunday or Monday before the election.

To vote **by mail** the resident must contact the Clerk and request a ballot by phone or mail and request to have a ballot mailed to them. The resident can then vote and mail the ballot back. Absentee voters require a witness to their voting that stipulates they are who they say they are.

College Students' Residence: Students may vote using their school address or their parents' address, but not both.

911 Fire Number Signs

The Town of Bangor has the responsibility of overseeing the 911 Fire Number System in the Township and seeing that fire numbers are in the proper location and easy to read.

These signs serve three main purposes: the first is to locate a site if an emergency occurs, the second is for the delivery of mail, and the third is to identify a specific property, tax parcel or lot.

Because of the first purpose, signs are placed in more locations than those needed for mail. Signs may be located by agricultural buildings where no residence is occupied but where a tractor rollover could happen. Public lands where people participate in recreation (horseback riding and skiing) are also assigned 911 numbers. Even telephone towers are assigned a number.

This program went into effect in 1980 and the first signs were paid for with a grant. Fire numbers are assigned by the County Zoning Department. Many Bangor signs need replacing. The Town Board will do a yearly inspection of all signs each spring and identify those that need replacing.

The maintenance of this system is a joint effort of the Town of Bangor and its residents. When signs need to be added or replaced, the Town orders the signs and installs them. Guidelines for placement of the signs say they should be 33 feet from the middle of the road and 9 feet to the right of the driveway. This placement removes them from much of the damage caused by snow plowing. There is some flexibility in the placement for obstructions, buildings etc. The homeowner should keep the sign free of bushes and grass that would obstruct its view.

The cost of the sign and post (if needed) is an expense of the owner. It will be billed to them and/or placed as a special charge on their property tax bill. Ordering the signs and installation will be done by the Town of Bangor.

Throughout the year new signs are also assigned when new construction occurs.

If homeowners want to have a new sign before the Board has indicated it necessary, they may contact the Clerk and be placed on the list for the next batch ordered.

Unacceptable Garbage

Hazardous materials

Cleaners, solvents, gasoline, oil, or other toxic, corrosive, explosive, or highly combustible materials may not be placed in the regular trash. Refer to the front page to see which hazardous materials are accepted at the La Crosse County Household Hazardous Materials Site. If in question, call the facility for a recommendation at 608-785-9999.

Vehicle parts, 250-gallon gas/fuel oil drums, other metal weighing 10 pounds or more

Take such materials to a salvage yard.

Commercial waste

Waste generated from commercial businesses is not accepted at the Drop-Off Site. Businesses must contract for refuse disposal.

You will receive a brochure like this at the beginning of each year, so please keep it! If you misplace it, pick one up at the drop-off site.

Town Hall

N4400 State Road 162, Bangor Wisconsin You may bring garbage and recyclables to this site Friday from 1:00pm to 5:00pm and Saturday from 8:00 am to noon. An attendant will be on site to direct you to the correct placement of your waste products and to collect any necessary fees.

Recycling Products

The La Crosse Household Hazardous Materials Site will accept unneeded material that may be of use to others such as paint, paint thinner, mineral spirits, lacquer, garden chemicals and fertilizer.

County residents may drop off and pick up items free of charge. This exchange is located at their dropoff center. (See outside of brochure.)

Garbage

Garbage bags may be purchased at Hanson's IGA, in the Village of Bangor and at the collection site. These bags are clear and have Town of Bangor printed on them. Fill them with garbage only. By sorting your waste into the appropriate containers you will spend less on bags. Kitty litter should be placed in bags with your garbage. See gray box on page 2 for unacceptable garbage.

Recyclables

Glass jars and bottles, with caps removed, tin and aluminum cans (including empty aerosol cans), plastic (#1 and #2 only) and liquid cartons like juice boxes can all be recycled. They are placed in a dumpster for commingled recyclables. Do not place wire in this container, as it causes problems with the sorting machines. Do not place ceramics, light bulbs or window glass in this container.

Paper Products

Newspapers, including ads on shiny paper, and cardboard are recycled. Keep them separate from other recyclables by putting them in a paper bag. There is a dumpster inside a building for these products so they are kept dry.

Appliances

Stoves, refrigerators, ovens, freezers, dishwashers, clothes washers and dryers, furnaces, boilers, water heaters, microwaves, air conditioners and dehumidifiers can be brought in to be recycled. A fee of \$25.00 is charged per item. Countertop appliances are charged a fee of \$2.00 per item.

Large Items

Large items like mattresses, boxsprings, rolls of carpet and pad, chairs and couches may be brought to the collection site for a charge. Mattresses and boxsprings: \$25.00 each, Rolls of carpet and pad: \$15.00 each. Couches and chairs: \$20.00 each.

Oil Filters

Used oil filters are no longer accepted at the Town of Bangor Collection Site. The Household Hazardous Waste Center (see outside of brochure) accepts them at no cost to La Crosse County residents.

Light Bulbs (tube & compact)

Fluorescent light bulbs can be taken to the Town of Bangor collection site. Place them inside the building in the designated spot. The Household Hazardous Waste Center (see outside of brochure) also accepts them at no cost to La Crosse County residents.

Incandescent bulbs can go with garbage.

Tires/Automotive Batteries

Tires may be dropped off for a fee. Car tires up to 16": \$10.00 each. Truck tires 16" and larger: \$15.00 each. Tractor tires, all sizes: \$20.00 each. Tires on a rim will be charged an extra \$5.00 per tire.

Automotive batteries are accepted at the town collection site for a fee of \$2.00 each.

Agriculture Waste

Ag waste includes plastics used to make silo and haylage bags, bunker silo covers, greenhouse covers, bale wrap, mulch film and other flexible products. These can be placed in the large-item dumpster that goes to the landfill. Bringing agricultural waste products in as you empty them is preferable to bringing a year's supply at once as the weight is easier to handle in small batches.

E-Waste

Electronics can be recycled. Computer towers, laptops, keyboards, mouse, scanners, printers, hard drives, circuit boards, etc: fee of \$5.00 each. Televisions and computer monitors: a fee of \$20.00 each. Television accessories (VCR/DVD players), gaming consoles, cable television receivers, etc.: a fee of \$5.00 each.

Salvaged Items

TVs and other appliances that have been salvaged are not accepted and sent to La Crosse. The HHM Program. See fees and information on Page 4 under E-Waste Recycling.

Batteries

Rechargeable batteries from phones and cameras must be recycled. Place tape over terminals to avoid contact with other terminals which can cause fire and/ or explosions.

Alkaline batteries may be placed in your regular garbage bags.

Construction Debris

Commercial construction waste like shingles and drywall are not acceptable. Contractors must contract with a hauler for their removal.

Refuse from handyman projects that can be cut into small boards that are no more than 4 feet in length and width can be placed in a dumpster.

Quantity loads

If large quantities of trash—like pickup loads—are brought to the collection site, the charge is \$10.00 for a car, \$20.00 for a van, SUV, \$15.00 for a 1/2 pickup load, \$25,00 for a pickup load and \$25.00 per axil for a trailer. The town site attendant has the authority to determine the charge for the load. Load charges DO **NOT** include charges listed separately in this brochure.

Disposal of Yard Waste and Brush

Yard waste consists of grass, leaves, and brush and should be composted on your property if possible.

You may burn it by calling the Town Chairman, Ken Manke 486-2642 (386-3393 cell) to request a verbal burning permit. If weather conditions are favorable he will grant you permission.

When permission is given, you then call the La Crosse Emergency Services Department, 608-785-9634, to tell them you have a verbal permit. They will record your fire number so that if concerned persons report it as a fire, they will know it is an approved burn. When your burn is completed you will be instructed to call them back with an all-clear message. You are to keep the fire under control.

Town of Bangor residents are also allowed to have a fire pit and/or a burn barrel on their property. Residents are cautioned to consider weather conditions and proximity to their neighbors. Smoke from burning garbage can is unhealthy. The ash, which some people place on their gardens, may contain heavy metals such as lead and cadmium. Ash, after it is cold for 2 weeks, may be bagged and placed in the large item dumpster for the

How to Prepare Recyclables

GLASS:


Jars and bottles only!

- NO light bulbs, dishes, glassware, window glass, mirrors, or ceramics.
- Remove lids and metal rings, empty, and rinse clean.



TIN CANS: Empty food, paint, aerosol cans only!

- NO chemicals, scrap metal, or vehicle parts.
- Empty, rinse clean, and remove labels. Ends of cans can stay attached. Flattening of food cans is appreciated.



- NO food or pie plates
- Drain liquid and rinse cans clean. Flattening is appreciated.



PLASTIC: Bottles only!

- NO plastic packaging, ice cream buckets, food containers, or Styrofoam.
- Look for #1 or #2 mark (milk jugs, soda and water bottles).
- Rinse clean; discard cap.



CARTONS: Milk, juice, broth, soup, and other food & beverage cartons

- What is a carton? It's a type of food and beverage packaging. There are two types: shelf-stable (broth, soup, soy milk, juice, milk, wine) and refrigerated (milk,
 - juice, cream, egg substitutes).
- Drain liquid.

Please Note: The Town recycles ONLY the items listed in this brochure. Items such as plastic packaging and nonrecyclable containers should be placed in with regular trash.

Place glass, tin cans, aluminum cans, plastic, and cartons together loosely in recycling bin.

NEWSPAPERS/MAGAZINES

- NO junk mail.
- Newspapers (including shiny inserts), magazines, and telephone books are acceptable.
- Keep papers as dry as possible!





Bundle newspapers and magazines with cotton string or place in a brown paper grocery bag and place in recycling bin inside building.

Safe Transportation of Hazardous Materials

- 1. If possible, bring items in their original containers, or clearly mark contents on container. If you do not know what is in the container, tell the attendant.
- 2. Tighten all covers and lids.
- 3. NEVER MIX CHEMICALS!
- 4. If a container is leaking, pack it separately in a leak-proof container (i.e. pail or tub)
- **5.** Do not load wastes in the passenger compartment of a vehicle.
- **6.** Avoid spills. Put waste containers, upright, in a sturdy container and place them securely in the trunk or back of a truck or van.
- 7. Do not put different types of wastes into a garbage bag.
- 8. Read and follow all directions when you arrive at the Household Hazardous Materials Facility.
- **9.** Gasoline and Used Oil should be transported in approved safety gas cans. Approved containers can be emptied and returned to the customer.

Unacceptable Materials at HHM

- Ammunition
- Radioactive Materials
- Black Powder
- Compressed Gas Cylinders
- ExplosivesFireworks
- Shock or Heat-Sensative Materials (Peroxide, Picric Acid)



SAVE YOURSELF A TRIP!

These items can and should go into your regular curbside trash or recycling:

- Empty paint and aerosol cans (recycling bin) Alkaline batteries (trash bin)
- Dried out paint cans (trash bin) Incandescent light bulbs (trash bin)

Sharps and Needles

"Sharps" must be brought to HHM in puncture resistant containers, including a registered, red "Sharps" container or a thick plastic laundry detergent bottle with a screw type cap.

NOTE: No other container will be accepted.

Acceptable Materials at HHM

- Pesticides, herbicides, rodenticides and other lawn and garden chemicals
- Paint, stain and varnish
- Oil, gasoline and other automotive fluids
- Household cleaning products
- Pool chemicals
- Fluorescent and compact fluorescent light bulbs
- Rechargeable, lead acid and lithium batteries
- Mercury thermometers, thermostats with mercury in them and other small mercury containing devices
- Sharps (see "Sharps and Needles" for proper packaging instructions)
- Handheld propane cylinders

E-Waste Recycling

These items are accepted at the Household Hazardous Materials Facility. Fees apply as noted (\$):

- TV's and computer monitors
- Video playing devices: VCR's, DVD players, gaming consoles, cable tv receivers etc.
- Computers: desktop towers/CPU's, laptops, tablets
- Computer accessories: printers, scanners, fax machines, keyboards, speakers, mice, external hard drives, flash drives/USB's, etc.
- Cell phones and digital cameras
- Microwaves and small Freon appliances \$

(\$) Fee Applies – see website or call for current pricing information. TVs and other electronics that have been salvaged or disassembled will be charged a fee per pound.

NON-HOUSEHOLD USERS?

Many businesses and organizations, including farms, in-home businesses, rental properties (landlords), churches, schools and municipalities generate small amounts of hazardous waste and are looking for an efficient means to dispose of such items. The current agreement between La Crosse County and all participating municipalities mandates that qualifying businesses and organizations must pay for the disposal of their materials at the HHM facility.

Steps for businesses and organizations:

- **1.** Prequalification is required. Call 785-9999 or visit: **www.lacrossecounty.org/solidwaste/hhm** to get qualification information, pricing and forms.
- 2. Fill out and return the "VERY SMALL QUANTITY
 GENERATORS (VSQG) CERTIFICATION FORM" and the
 WASTE INVENTORY FORM". The completed forms can be
 emailed to hhm@lacrossecounty.org
- **3.** Once the forms have been submitted to and approved by HHM staff, we will call you to set up an appointment to drop off your materials. Businesses and organizations will not be allowed to drop off waste without an appointment.
